The request for proposals document in English may be purchased by interested eligible Proposers upon the submission of a written application to the address below and upon payment of a nonrefundable fee of **PKR. 15,000** (Pakistani Rupee Fifteen Thousand Only) or equivalent amount through a pay order or demand draft in favour of the Project Director, Competitive and Livable City of Karachi, Investment Department, Government of Sindh.
- 6. Proposals must be delivered to the address below [state address at the end of this RFP on or before 03:00 PM (PST) on 25th June, 2024 Electronic procurement will not be permitted. Late Proposals will be rejected. The outer Proposal envelopes marked "ORIGINAL PROPOSAL", and the inner envelopes marked "TECHNICAL PART" will be publicly opened in the presence of the Proposers' designated representatives and anyone who chooses to attend, at the address below on 03:00 PM (PST). All envelopes marked "FINANCIAL PART" shall remain unopened and will be held in safe custody of the Purchaser until the second public Proposals opening.
- 7. All Proposals must be accompanied by a **Proposal Security** of USD 50,000/- or equivalent amount in the same currency of bid amount.
